

ORDINANCE NO. 176292

An ordinance amending Chapter 1, Article 14 of Division 10, of the Los Angeles Administrative Code to provide for administrative changes to the Contractor Responsibility Program.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection (b) of Section 10.40.1 of the Los Angeles Administrative Code is amended to read:

(b) **“Contract”** means any agreement for the performance of any work or service, the provision of any goods, equipment, materials or supplies, or the rendition of any service to the City or to the public, or the grant of City financial assistance or a public lease or license, which is let, awarded or entered into by or on behalf of the City of Los Angeles. Contracts for services and for purchasing goods and products that involve a value in excess of twenty-five thousand dollars (\$25,000) and a term in excess of three months are covered by this Article. Construction contracts are covered by this Article without regard to contract amount and term.

Sec. 2. Subsection (c) of Section 10.40.2 of the Los Angeles Administrative Code is amended to read:

Questionnaires will be public records and information contained therein will be available for public review, except to the extent that such information is exempt from disclosure pursuant to applicable law. The awarding authority may rely on responses to the questionnaire, information from compliance and regulatory agencies and/or independent investigation to determine bidder responsibility.


Sec. 3. Subsection (a) of Section 10.40.5 of the Los Angeles Administrative Code is amended to read:

(a) The DAA shall promulgate rules and regulations for implementation of this Article.


Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located in the Main Street lobby to the City Hall; one copy on the bulletin board located at the ground level at the Los Angeles Street entrance to the Los Angeles Police Department; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.



DECLARATION OF POSTING ORDINANCE


