
(a) having a household income of less than 50% of the Area Median Income (AMI), o





Criteria (1) having a Veteran status; having documented history of involvement with the criminal justice system; or being homeless.

Criteria (2) is an individual facing two of the following barriers to employment: having a household income of less than 50% of the Los Angeles County's median annual household income, receiving public assistance, lacking a GED or high school diploma, being a custodial single parent, suffering from long-term unemployment, being emancipated from the foster care system, or being an apprentice with less that 15% of the apprenticeship hours required to graduate to journey level in a program as described in Section 1.3 of the PLA Agreement.
